#### TUITION PAYMENTS

**If mailing your tuition deposit, please notify us through e-mail at [info@a2oca.org](mailto:info@a2oca.org) and include a copy of your completed and signed Tuition Contract Agreement.** There may be the option to make the tuition deposit and payments through electronic funds transfer. If interested in this option, please contact us at [info@a2oca.org](mailto:info@a2oca.org) for more information on how to enroll.

Tuition for those wishing to enroll in the single payment plan (see option 1) is reduced slightly and due before the start of classes in October 2021 (exact date TBA), unless alternate arrangements have been made in writing with Irene Melabiotis, the Head of School (Interim), at

imelabiotis@a2oca.org. Tuition for those wishing to enroll in the trimester payment plan (see option 2) or monthly payment plan (see option 3) involves paying the tuition deposit in advance to secure the child's enrollment (due at the time of application submission, unless alternate arrangements have been made in writing with the Head of School), with the remainder of tuition divided into several equal payments, depending on the payment plan chosen.

If at any point you experience difficulty making a tuition payment, please reach out to us as soon as you are able to, so that we can work together to find a solution.

### **TUITION DISCOUNT**

Ann Arbor Orthodox Classical Academy is committed to offering an education that is financially accessible to all families who wish to make A2OCA a part of their and their children's lives. Discounts are available for multiple children from the same family. Kindly note that this type of discount does not apply to the tuition of the oldest enrolled child. Families seeking tuition assistance with more than four children enrolled at A2OCA are encouraged to contact the Head of School to discuss tuition options.

### **TUITION PAYMENT PLANS**

Please select your preferred tuition payment plan from the following three options:

**OPTION 1: SINGLE PAYMENT PLAN**

\* tuition for those wishing to pay tuition in full prior to the first day of classes (in October 2021; exact date TBA) is reduced to \$1155 (for **Kindergarten**) and \$1325 (for **1st Grade** or **2nd Grade**)

\* full payment of the year's tuition is due at the time of submission of this Tuition Contract (unless prior arrangements have been made in writing with the Head of School)

\* tuition discounts available for multiple enrolled children in this payment plan: \$75 off tuition for the second Child, \$100 off tuition for the third Child, and \$125 off tuition for the fourth and subsequent Child

\* for payment by personal check, please include memo: 'Full Tuition, A2OCA Online'

\* any account that does not meet the deadline for full tuition payment (unless prior arrangements have been made in writing with the Head of School) will automatically be enrolled in Option 2 (Trimester Payment Plan)

\* once payment of full tuition is made, it is non-refundable

**OPTION 2: TRIMESTER PAYMENT PLAN**

\* regular tuition for **Kindergarten** is \$1215 (tuition deposit of \$165 due at the time of submission of this Tuition Contract; \$350 is paid each trimester thereafter; payments due October 31st, January 31st, and April 30th)

\* regular tuition for **1st Grade** or **2nd Grade** is \$1395 (tuition deposit of \$195 due at the time of submission of this Tuition Contract; \$400 is paid each trimester thereafter; payments due October 31st, January 31st, and April 30th)

\* tuition deposit is non-refundable

\* tuition discounts available for multiple enrolled children in this payment plan: \$150 off tuition for the second Child, \$200 off tuition for the third Child, and \$250 off tuition for the fourth and subsequent Child

- \* for payment by personal check, please include memo: 'Trimester Tuition, A2OCA Online'
- \* in the case of student withdrawal from the program, sixty (60) days' written notice must be submitted to Irene Melabiotis, the Head of School (Interim), at [imelabiotis@a2oca.org](mailto:imelabiotis@a2oca.org); please note that the tuition due during the 60-day notice period will be billed to the family account; if this amount has been paid in advance, it is non-refundable

**OPTION 3: 7-MONTH PAYMENT PLAN**

- \* regular tuition for Kindergarten is \$1215 (tuition deposit of \$165 due at the time of submission of this Tuition Contract; monthly tuition payments of \$150 due by the end of each month from October to April)
- \* regular tuition for 1st Grade or 2nd Grade is \$1395 (tuition deposit of \$184 due at the time of submission of this Tuition Contract; monthly tuition payments of \$173 due by the end of each month from October to April)
- \* tuition deposit is non-refundable
- \* tuition discounts available for multiple enrolled children in this payment plan: \$150 off tuition for the second Child, \$200 off tuition for the third Child, and \$250 off tuition for the fourth and subsequent Child
- \* for payment by personal check, please include memo: 'Monthly Tuition, A2OCA Online'
- \* in the case of student withdrawal from the program, sixty (60) days' written notice must be submitted to Irene Melabiotis, the Head of School (Interim), at [imelabiotis@a2oca.org](mailto:imelabiotis@a2oca.org); please note that the tuition due during the 60-day notice period will be billed to the family account; if this amount has been paid in advance, it is non-refundable

**TUITION ASSISTANCE**

If you intend to apply for tuition assistance, the amount awarded will be deducted from the regular tuition amount, and you will be responsible for paying the tuition deposit and the remaining balance divided into several equal payment payments, depending on the payment plan chosen.

**ADDITIONAL FEES**

Tuition Fees do not include the cost of consumable materials from Kindergarten to 2nd Grade and any private lessons that the student may undertake to support his or her learning.

**LATE FEES AND NSF CHECKS**

Any account that does not meet a payment deadline (unless prior arrangements are made with the Head of School) will be charged the associated late fee. For the monthly payment plan, this fee is \$10; for the trimester payment plan, this fee is \$25. For the single payment plan, this fee is \$75. For any personal checks returned due to non-sufficient funds (or 'NSF'), a fee of \$20.00 will be assessed to the account.

## TERMS AND CONDITIONS

### Payment of Tuition

1. Tuition for the 2021–2022 school year shall be paid in full by the due date(s), in accordance with the tuition payment deadline(s) set out in your selected tuition payment plan.
2. If a tuition payment is forty-five (45) days overdue, A2OCA may take any or all of the following actions, at the School's sole discretion, unless special payment arrangements have been made in writing and signed by the Head of School:
  - (a) Assess late fees on account in arrears
  - (b) Withhold academic records, transcripts, or diploma
  - (c) Withdraw student from class
  - (d) Send account in arrears to collection agency
3. Any student account with an unpaid tuition and/or fees balance for the current school year will not be permitted to register for the next school year until the current year's tuition and fees are paid, unless special arrangements have been made in writing and signed by the Head of School. School records, transcripts, or diplomas will not be released until all outstanding tuition charges and fees have been paid in full.
4. If one parent signs the Tuition Contract when married, both are liable for the student's school tuition; if one parent signs the Tuition Contract after they are divorced, only that parent is liable to pay the student's school tuition; if someone other than a parent signs the Tuition Contract, neither parent is liable and the signee is liable to pay the student's school tuition.

### Refunds

5. For those wishing to withdraw enrollment of their child(ren) under the option 1 payment plan, sixty (60) days' written notice to Irene Melabiotis, the Head of School (Interim), is required at [imelabiotis@a2oca.org](mailto:imelabiotis@a2oca.org). Please note that full prepaid tuition is non-refundable.
6. For those wishing to withdraw enrollment of their child(ren) under either the option 2 or option 3 payment plan, sixty (60) days' written notice to Irene Melabiotis, the Head of School (Interim), is required at [imelabiotis@a2oca.org](mailto:imelabiotis@a2oca.org). Please note that the tuition due during the 60-day notice period will be billed to the family account; if this amount has been paid in advance, it is non-refundable.

7. A2OCA reserves the right to withdraw a student from the online learning program if a student or parent/legal guardian has broken the School covenant three times, after two prior written communications about such future actions resulting in the student's withdrawal from the School. In such instances, full prepaid tuition is non-refundable and those with outstanding annual tuition balances on their accounts will be responsible to pay those amounts in full.

### **General Terms and Conditions**

8. I/We acknowledge that the terms and conditions of the School's policies, which are available on the A2OCA website (and a hard copy of which can be provided to me upon request), are hereby incorporated into this Agreement.

10. I/We acknowledge that my/our student(s) and we will abide by the School policies and guidelines as communicated in the Parent–Student Handbook.

11. I/We acknowledge that if two checks are returned for NSF, A2OCA will no longer accept personal checks and I/we will be required to pay any school fees in cash or by certified check from a local bank.

12. I/We acknowledge that A2OCA will not reserve a place for my/our student(s) for the 2021-2022 school year until after I/we have submitted a completed and signed Tuition Contract, along with all necessary documents and my tuition deposit for each enrolled student (if applicable). I/We further acknowledge that my/our student's eligibility for re-enrollment for the 2022–2023 is conditioned upon his/her successful completion of the current school year's curriculum and upon full payment of all tuition and fees owed for the current and/or prior school years.

13. I/We acknowledge that A2OCA reserves the right to deny enrollment to any student that the School determines is unsuitable for enrollment. Such instances may be determined by (a) the student's performance on the entrance assessment or (b) the School's inability to adequately provide the necessary learning supports for students with special learning needs. I/We acknowledge that the School reserves the right to ask a student to withdraw from the School if the student or parent/legal guardian has broken the School covenant three times after two prior written communications about the actions/behaviors resulting in withdrawal from the School.
